“High Court” means the Original Side of the High Court at Bombay. Application by Advocate for registration :- An Advocate, desiring to act for any party in any suit or proceeding, other than those referred to in rule 5 below, in the High Court, shall apply to the Prothonotary and Senior Master to enter his name in the Register of Advocates.
