Foreign nationals who are immediate family members of Canadian citizens and permanent residents, and who do not have COVID-19 or exhibit any signs or symptoms of COVID-19, or who do not have reason to believe they have COVID-19, are exempt from the prohibition on entry to Canada if entering to be with an immediate family member for at least 15 days.
